SUMMARY OF THE PROCEEDINGS OF 41st ANNUAL GENERAL MEETING

DATE, TIME AND VENUE OF THE MEETING

- The 41st Annual General Meeting of the Company was held on Wednesday, September 24, 2025 at 1.00 PM through Video Conferencing.

PROCEEDINGS IN BRIEF

- Mr. Alok Kr. Behera, Chairman & Managing Director of the Company occupied the chair.
- Total 33 members were present in the meeting.
- As per Section 103 of the Companies Act, 2013 the required quorum for convening the AGM was present, accordingly the Chairman called the meeting in order.
- The Chairman informed to the members that the Company is in compliance the requirement of applicable Act and the Rules and the Secretarial Standards made there under with respect to calling, convening and conducting the meeting.
- The Chairman welcomed the Members to the 41st AGM of the Company through Video Conferencing (VC). The Chairman introduced the Directors present and Round Call was taken. He informed that since the meeting was being conducted through VC there was no requirement for proxies. He further informed that the Register of Members, Register of Director's and Key Managerial Personnel and their shareholding, Register of Contracts, etc. were kept open for inspection by Members and the same were accessible in electronic mode to those shareholders who shall place request for the same.
- With the consent of the Members present the notice of the 41st AGM and the Auditor's Report were taken as read by the Chairman.
- The Chairman read out the details of remote e-voting and instructions for AGM. He stated that in accordance with the provisions of the Companies Act, 2013, and the rules made thereunder, the remote e-voting facility for voting on the resolution(s) contained in the Notice of the 41st AGM was provided to the Members of the Company from 9.00 am on 21st September 2025 and up to 5.00 pm on 23rd September, 2025 and that the e-voting module was closed by NSDL thereafter.
- Two Members have registered themselves as speaker for the AGM but none of them have appeared in the meeting. Thereafter, the Chairman requested the Members who are present in the meeting and have not voted through remote e-voting, to vote through the e-voting process provided at the AGM. Mrs. Kriti Daga, Practicing Company Secretary was appointed as Scrutinizer for scrutinizing the remote e-voting and e-voting at the AGM.
- The following items of business as set out in the notice convening 41st AGM were placed for members' consideration and approval.

ORDINARY BUSINESS:
